TAXPAYER'S NOTICE

As per state statute, the ownership and valuation of all real and personal property subject to taxation is fixed as of April 1, 2012. Real estate taxes are due in two installments with the first due 10/15/2012 and the second due 04/16/2013. Personal property taxes are due in a single installment on 10/15/2012. INTEREST AT THE RATE OF 7% PER ANNUM IS CHARGED ON ALL TAXES UNPAID AS OF THE DUE DATE(S). Collection is enforced in accordance with Maine law. This bill is only for the current tax year. Past amounts due, if any, are not included.

INFORMATION

Your tax bill has already been reduced by approximately 26% due to funding the Town of Brunswick anticipates will be received from the State of Maine in the form of Revenue Sharing and Education Aid. For qualifying Maine residents, your tax bill may have already been further reduced by the Homestead Exemption. One-half of the funding for that program is provided by the State. The amount of value, if any, exempt under that program is shown above. Questions regarding valuations or exemptions should be directed to the Tax Assessor at 207-725-6650. Questions regarding payments should be directed to the Tax Collector at 207-725-6657. As of June 30, 2012, the amount of the Town of Brunswick's principal debt outstanding was \$27,439,138. Additional debt is authorized but not issued.
