As per state law, the ownership and valuation of all real and personal property subject to taxation shall be fixed as of April 1st. For this tax bill, that date is April 1, 2012. If you have sold your real estate since April 1, 2012, it is your obligation to forward this bill to the current property owner.

If you have an escrow account, please forward a copy to your mortgage holder prior to the due date.

If you would like a receipt, please send a self-addressed stamped envelope with your payment.

As of July 11, 2012 the Town of Searsport has bonded indebtedness in the amount of \$643,018.09.

INFORMATION

This bill is for the current tax year, January 1, 2012 to December 31, 2012. Past due amounts are not included. REVENUE SHARING AND STATE AID TO EDUCATION HAVE ALREADY REDUCED LOCAL PROPERTY TAXES FOR THE FISCAL YEAR BY APPROXIMATELY 32%. Delinquent taxes will be published; tax liens will be placed within 12 months of commitment; interest, costs and fees will be charged. Any appeal from this bill must be made to the Searsport Assessor in accordance with the statutory provisions of the laws of the State of Maine.
