NOTICE TO TAXPAYERS

INTEREST AT 7 % PER ANNUM CHARGED AFTER 9/19/2014 AND 2/6/2015.

Notice is hereby given that your first payment of municipal tax is due by 9/19/2014 and the second payment is due by 2/6/2015. Interest will be charged on unpaid taxes at an annual rate of 7 % beginning 9/20/2014 and 2/7/2015. As per state statute, the ownership and taxable valuation of all real and personal property subject to taxation shall be fixed as of April 1st of each year. For this tax bill, the date is April 1, 2014. This tax bill is for the fiscal period beginning July 1, 2014 and ending June 30, 2015.

For information regarding payments, interest, and/or refunds, please contact the Tax Collector at 207-363-1003. Information regarding changes OR information regarding valuations, please contact the Tax Assessor's Office at 207-363-1005.

Without State Aid for Education, Homestead Exemption reimbursement, BETE Exemption reimbursement, and State Revenue Sharing, your tax bill would have been 3.53 % higher. After 8 months and no later than one year from the date of commitment, a lien will be placed on all real estate for which taxes remain unpaid. If you escrow your taxes, please forward this bill to your bank.

As of July 30, 2014 the Town of York has outstanding bonded indebtedness in the amount of \$28,997,021.
