TAXPAYER'S NOTICE

Notice is hereby given that your school, county and municipal property tax is due by 10/27/2014 and 04/27/2015. Interest will be charged on unpaid taxes at an annual rate of 7% beginning 10/28/2014 and 04/28/2015.

Per State law, the ownership and valuation of all real estate and personal property subject to taxation shall be fixed as of April 1st. This bill is for the current fiscal year only.

Please call the tax collector regarding past due amounts, payments, interest and refunds. All tax payments received are applied to the oldest outstanding tax. After eight months and no later than one year from the date of commitment, a lien will be placed on all real estate for which taxes remain unpaid.

INFORMATION

Without State Aid for Education, Homestead Exemption Reimbursement and State Revenue Sharing, your tax bill would have been 58% higher.

As of the date of this bill, the Town of Oxford has a total outstanding bonded indebtedness in the amount of \$15,563,853. T.I.F. Tax shelter implemented on Rt. 26 shifted approximately \$396,000 from school and county cost into infrastructure revenue.
